

## **Travel Girl, Travel World Terms & Conditions**

As a valued client of Travel Girl, Travel World (the Agency), we strive to provide you with a secure and trustworthy travel booking experience. To maintain the integrity of our services and protect against any fraudulent activity, we encourage you to carefully read through the Terms & Conditions outlined below.

### Payment Acknowledgement:

You acknowledge that all the information you provide is accurate. By submitting a payment authorization form, you provide authorization for Travel Girl, Travel World, authorized agents of Travel Girl, Travel World, and/or the travel supplier (ALG Vacations, Apple Vacations, Blue Sky Tours, Funjet Vacations, Southwest Vacations, Travel Impressions, United Vacations, Universal Parks & Resorts Vacations, Carnival, Royal Caribbean, Virgin Voyages, or any other supplier Travel Girl, Travel World chooses to use) to charge your card for the amount indicated.

Note that completing the form does not process your payment immediately. Once submitted, it simply authorizes the Agency to process a payment on your behalf. Payment can take up to several business days to fully process and reflect on your statement.

### Client Responsibilities:

As a Client of Travel Girl, Travel World you agree to provide accurate and complete information regarding credentials, travel preferences, dates, and all personal information necessary for bookings. You are responsible for ensuring that you have valid, up-to-date travel documentation such as a personal identification card, driver's license, passport, etc.

Travelers must comply with all entry requirements, health regulations, customs laws, and other legal stipulations of the countries they plan to visit. Please consult your travel agent/advisor to learn about the requirements of each travel location.

You, the Client, agree to pay all fees (including service fees) to the Agency as stipulated in these Terms & Conditions, as well as any additional costs incurred for transportation, accommodations, tours, and other travel-related services. Payments must be made within the specified time frame provided by the Agency.

The Client knowingly accepts any risks associated with travel, including but not limited to political instability, health hazards, and natural disasters. You agree to stay informed about the current conditions in your travel destination(s) and will make informed decisions.

### Cancellations, Changes, and Refunds:

In the event you wish to cancel a booking, you may be subjected to cancellation fees as per the policies of the travel suppliers (airlines, hotels, tour operators, etc.). The Agency will assist in securing refunds where possible but cannot guarantee the amount or timing of such refunds.

If the Agency cancels any bookings due to non-payment or other breaches of these Terms & Conditions, you will not be entitled to a refund of any service fees.

#### Travel Insurance:

The purchase of travel insurance is not required but is highly encouraged. If you choose not to purchase travel insurance, you will be required to sign a waiver acknowledging your decision to decline coverage and assume all risks associated with that decision. By declining travel insurance, you agree that the Agency shall not be held liable for any losses, damages, or additional costs incurred as a result of events that could have been covered by travel insurance.

#### Chargebacks:

Initiating a chargeback without a valid reason or prior communication with Travel Girl, Travel World is considered a breach of these Terms & Conditions. In such cases, Travel Girl, Travel World reserves the right to pursue legal action to recover any/all incurred costs, including but not limited to legal fees and other associated expenses.
